THIS REPRESENTS A 4X INCREASE FROM THE PREVIOUS YEAR'S PERFORMANCE. OUR DIRECT SERVICES INCLUDE THE IDENTIFICATION, TRIAGE AND REFFERAL OF OVER 1,000 DIFFERENT SERVICES FOR THESE SERVICES. ALLOWING EACH FAMILY TO RECIEVE THE SUPPORT AND OPPORTUNITY TO REALIZE THEIR UNIQUE GOALS.
