IN 2016, THIS PROGRAM SERVED 1,188 FAMILIES THROUGH 2,954 SERVICES; AN AVERAGE OF 2.5 NEEDS PER FAMILY. OUR MOST REQUESTED SERVICES WERE EMPLOYMENT, HOUSING, AND FINANCIAL ASSISTANCE, WITH 65% OF THOSE REQUESTS BEING SUCCESSFULLY CLOSED. LAST YEAR, WE SERVED MORE VETERANS THAN IN 2011-2015 COMBINED. OUR PROGRAM METHODOLOGY HAS EVOLVED TO ACCOMMODATE THE INCREASING NUMBER OF SERVICE MEMBERS LEAVING THE MILITARY, BUT OUR MISSION TO BEST SUPPORT EACH VETERAN HAS REMAIN UNCHANGED.

WITH A NATIONAL AVERAGE OF \$100.00 PER HOUR, WE HAVE SAVED VETERANS A MINIMUM OF \$33,000 AND SUPPORTED THE HOLISTIC HEALTH OF EACH INDIVIDUAL WHO REQUESTS SERVICES.
