VETERANS BRIDGE HOME SERVES AS AN ENTRY POINT FOR RETURNING MILITARY VETERANS BY IDENTIFYING THEIR EDUCATION, HEALTHCARE AND EMPLOYMENT NEEDS AND CONNECTING THEM TO THE RIGHT COMMUNITY ORGANIZATIONS AND STATE AND FEDERAL RESOURCES. THE ORGANIZATION IDENTIFIES SERVICE GAPS

VETERANS BRIDGE HOME LEADS A COLLECTIVE IMPACT MODEL CALLED NCSERVES, ORCHESTRATING 50 DIFFERENT ORGANIZATIONS IN A TRANSPARENT AND ACCOUNTABLE NETWORK OF SERVICES TO MEE THE HOLISTIC NEEDS OF EACH VETERAN FAMILY. IN 2018, THIS PROGRAM SERVED 1,314 FAMILIES THROUGH 3,214 SERVICES; AN AVERAGE OF 2.4 NEEDS PER FAMILY. OUR MOST REQUESTED SERVICES WERE EMPLOYMENT, HOUSING AND FINANCIAL ASSISTANCE, WITH 67% OF THOSE REQUESTS BEING SUCCESSFULLY CLOSED. LAST YEAR, WE SERVED 7% MORE VETERANS THAN IN 2011-2017 COMBINED. OUR PROGRAM METHODOLOGY HAS EVOLVED TO ACCOMMODATE THE INCREASING NUMBER OF SERVICE MEMBERS LEAVING THE MILITARY, BUT OUR MISSION TO BEST SUPPORT EACH VETERAN HAS REMAINED UNCHANGED.

OUR ORGANIZATION LEADS THE CHARLOTTE VETERANS' NETWORK, WHICH IN 2018 HOSTED 4,352 VETERANS AND SUPPORTERS THROUGH 316 EVENTS. 396 OF THESE VETERANS REGISTERED WITH OUR PROGRAM AS NEW MEMBERS AND HAVE BECOME MORE ENGAGED IN THEIR COMMUNITY THROUGH NETWORKING, FITNESS, RECREATION, AND VOLUNTEERING OPPORTUNITIES. WE HAVE BEEN ABLE TO PROVIDE THESE VETERANS WITH MEANS TO INCREASE THEIR SOCIAL CAPITAL, RESULTING IN A MORE SUSTAINABLE COMMUNITY AND AN INCREASED SENSE OF INDIVIDUAL WELLBEING

OUR NO COST MENTAL HEALTH COUNSELING SERVICES, CONDUCTED BY A PSY.D AND LPC, ARE PROVIDED TO VETERANS SEEKING PERSONAL AND PROFESSIONAL SUPPORT DURING TRANSITION. CURRENT OFFERINGS FROM THE VBH TRANSITION CENTER INCLUDE CLINICAL CASE MANAGEMENT, INDIVIDUAL AND FAMILY HEALTH AND WELLNESS CONSULTATIONS, INDIVIDUAL AND MARITAL THERAPY, CRISIS INTERVENTION, AND PSYCHOEDUCATION TRAINING FOR THE GREATER COMMUNITY. IN 2018, WE PROVIDED 485 COUNSELING SESSIONS WITH 151 CLIENTS AND 184 INDIVIDUALS WERE TRAINED ON VETERAN MENTAL HEALTH BEST PRACTICES. WITH A NATIONAL AVERAGE OF \$100 PER HOUR, WE HAVE SAVED VETERANS A MINIMUM OF \$48,000 AND SUPPORTED THE HOLISTIC HEALTH OF EACH INDIVIDUAL WHO REQUESTS SERVICES.
