

## **Contest Rules**

### **1. Eligibility**

VBH & RWR NASCAR Giveaway (the "Contest") is open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Veterans Bridge Home and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

### **2. Sponsor**

## **5. How to Enter**

Online: This method of entry will be available by visiting our website ([www.veteransbridgehome.org/nascar](http://www.veteransbridgehome.org/nascar) and following the directions provided to fill out the entry information, and submit.

Via Text Message: This method of entry will be available for the entire Contest Period. Send a text message with Give2Vets from your handset to the short code 243725. In response to this text message, an auto-reply will be sent to the device. Follow the directions provided in the reply to confirm your entry. Standard text and data rates will be charged for each text message sent or received from your handset according to the terms of your carrier. Check with your wireless carrier for your handset capabilities and pricing plan details.

Via Mail: This method of entry will be available for the entire Contest Period. On a 3x5 card, handprint your full name, complete address, phone number (including area code) date of birth and email address (optional) and mail in an envelope with proper postage affixed to: 4117 Park Road Box 11966, Charlotte, North Carolina, 28209  
Mail-in entries must be hand-printed and mailed in separately. All mail-in entries must be postmarked by October 11, 2020 and received by October 11, 2020.

## **6. PrizeDrawing**

On or about October 12, 2021, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about October 12, 2020. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact

him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

## **7. Winner Notification**

The potential winners will be notified by email, mail or phone. Each potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. ## **9. General Conditions**
