IN 2019, VETERANS BRIDGE HOME AND NCSERVES METROLINA CONNECTED 1,841 VETERAN SERVICE MEMBER FAMILIES, A 38% INCREASE, TO 3,934 SERVICES, AN AVERAGE OF 2.1 SERVICE PER FAMILY.
